Dear Ms. Dortch:

MNA Holdings, LLC ("MNA Holdings") and Bluebird Media, LLC ("Bluebird Media"), by their undersigned counsel, file this letter to supplement the above-referenced application for approval of the transfer of control of Missouri Network Alliance, LLC ("MNA") (the "Application").

As described in the Application, MNA is a direct wholly owned subsidiary of Bluebird Network, LLC ("Bluebird Network"). Bluebird Media holds a 50 percent ownership interest in Bluebird Network. Richard Otto Maly holds a 51 percent ownership interest in Bluebird Media, and Christopher Martin and Tatum Martin each hold a 20 percent ownership interest in Bluebird Media.

MNA holds a 10 percent direct ownership interest in Illinois Network Alliance, LLC ("INA"), which provides service in Illinois, Kentucky, and Tennessee. Pursuant to an operating agreement with INA, MNA manages the day-to-day operations of INA's business, including business development (marketing and sales), network provisioning and maintenance, accounting services, and business planning. INA also serves as a third-party network provider to MNA.

Under the Commission's rules governing attribution of ownership interests,<sup>1</sup> Bluebird Network, Bluebird Media, and Richard Otto Maly each hold an indirect ownership interest of ten percent in INA. Apart from their respective interests in INA, Bluebird Network, Bluebird Media, and Richard Otto Maly do not hold an ownership interest of ten percent or greater in any other domestic telecommunications provider.

Neither Christopher Martin nor Tatum Martin holds an ownership interest of ten percent or greater in any domestic telecommunications provider.


