The filing window was much sooner this year than it was last year and I did not have the details needed in time to certify our form 470, as a request for bids. Our original form 470 application (#180030249) was created on 2/22, which was the deadline, but was not able to certify until 2/26 after receiving information needed internally from staff. Later, I discovered that I submitted the original form 470 application under the wrong category and had to create yet another form 470 (#180031137). This was created and certified on 2/27, which was 5 days after the deadline to file a form 470 application. I hope that you would consider helping our school by making this eligible for funding, so that we can install battery backup units in our school network racks, to keep critical systems running during power outages.
