All Hallows High School is located in the Bronx, New York and relies on Erate services to assist in the education of their students.

On March 27, 2019, while attempting to file the 471's for Category 1 and Category 2 services for internet and internal hardware connections respectively, I experienced a technical issue which caused me to miss the filing deadline. I was logged out several times for reasons unknown and my access was blocked.

I called USAC and they told me that I would have to wait 65 minutes to be able to log into the site again. By the time I was able to log into the site the deadline has passed.

I have attached the email providing me a case number as well as the notices that my 471's were ready to be reviewed and then certified prior to the 11:59 deadline. I have subsequently filed the 471's (see attached)

I am asking for a waiver to extend the filing time for two hours past the midnight deadline.

The Erate funding is critical for a school located in the South Bronx.
