Immanuel Lutheran School is requesting a Waiver of USAC's decision not to fund the above 471 application and associated funding request: USAC has Immanuel Lutheran School's FCC Form 471 – 191041634 for Funding Year 2019 on 3/30/2019, "Your application is being filed after the close of FY 2019 filing window. Therefore, your application will not be considered for funding."

I. INTRODUCTION AND SUMMARY

Immanuel Lutheran School submitted and certified their Funding Year 2019 FCC Form 471 # 191041634, in the "Create FCC Form 471" section of the Schools and Libraries Division ("SLD") of the Universal Service Administrative Company's ("USAC") EPC Portal, on March 30, 2019, just 3 days after the FCC Form 471 filing deadline of March 27, 2019. See attached acknowledgment page from EPC.

II. REQUEST

Immanuel Lutheran School respectfully petitions the Commission to request a waiver of the Funding Year 2019 FCC Form 471 filing deadline on behalf of the School to allow the Out of Window submission of their E-Rate Funding Year 2019 FCC Form 471 #191041634, due to:

The applicant's original FCC Form 470 was filed on 11/6/18 with an ACD of 12/4/18. After review and evaluation of the bids received, the applicant questioned whether or not their original posting was adequate to meet the schools "Internal Connections" needs. (4) Services providers did a walk through the school, at which time all questions were discussed and answered to the best of the abilities of the technical staff; thereupon the applicant determined that they would need to file a supplemental FCC Form 470 in order to meet their needs. An FCC Form 470 was filed on 3/2/19 with an ACD of 3/30/19. In order to be in compliance with the competitive 28-day waiting period, the applicant's FCC Form 471 could not be filed before the ACD of 3/30/19. The applicant's FCC Form 471 application #191041634, was filed shortly thereafter.
