On March 28, 2019, representatives of Securus Technologies, Inc. (“Securus”), Inmate Calling Solutions, LLC d/b/a ICSolutions (“ICS,” and together with Securus, “Applicants”), and Keefe Group, LLC (“Keefe”)<sup>1</sup> met with the Federal Communications Commission (“FCC” or “Commission”) Staff listed in Exhibit A from the (1) Office of Chairman Ajit Pai (“Chairman’s Office”); (2) Wireline Competition Bureau (“WCB”), including Staff from the Office of the Bureau Chief, the Competition Policy Division (“CPD”), and the Pricing Policy Division (“PPD”); and (3) Office of General Counsel (“OGC”). 
