Dear Ms. Dortch:

Pursuant to Section 1.1206(b) of the Commission’s Rules, 47 C.F.R. § 1.1206(b), notice is hereby provided of a written *ex parte* presentation in the above-referenced docket. By this filing, T-Mobile US, Inc. and Sprint Corporation (collectively, “Applicants”) submit the attached *errata*, marked as Attachment A to this letter, to Exhibit 10 from the February 6, 2019 Response to Dish Comments Regarding Diversion Ratios by Drs. John Asker, Timothy Bresnahan, and Kostis Hatzitaskos (the “February 6 Response”).¹

These *errata* correct two numbers in Exhibit 10. As a result of a coding error, the amounts reported for compensating variation for the two nested logit models were \$.02 (two cents) different than the amounts that should have been reported. The version of Exhibit 10 attached as Appendix A corrects this. The two cent difference is immaterial to the underlying economic analysis. The Applicants submit these *errata* in the interest of transparency and to ensure the accuracy of the Commission’s record in this proceeding.
