Narrative

Devine ISD decided on the Self Provisioned fiber product due to its long range cost benefits for both USAC and the school district. Example, USAC has been spending roughly \$33,000 per year for lit fiber services for many years. Based upon this figure the recovery period would be roughly 4.6 years without any further reoccurring costs on this project or to these 3 locations as outlined. This project also raises the connectivity speeds from 1,000 Mbps to 10,000 Mbps. Devine ISD intends to perform any needed maintenance and repairs out of local funds. Project details are outlined in the Devine ISD Cat1 ERATE 2018-job specs.pdf. Devine ISD has opted to upgrade the fiber project from 2 strands to 12 strands in the fiber count. Devine ISD will and or is willing to incur any charges above the 2 strand count. However, in this case the 12 strand fiber cost is less due to availability and product demand. Only 2 strands will be lit per location.
