I. INTRODUCTION AND SUMMARY

The North Lawndale College Prep Charter High School (“NLCP”) serves Grades 9 through 12 in the North Lawndale community of Chicago. NLCP has been a successful recipient of the E-rate program for numerous years and its students have benefitted greatly from the added resources as the campuses are situated in a high poverty and under resourced community.

NLCP submitted and certified their Funding Year 2019 FCC Form 471 #191041619 in the Online portal of the Schools and Library Division (“SLD”) of the Universal Service Administrative Company’s (“USAC”) website on March 29th, 2019, just 2 days after the FCC Form 471 filing deadline of 2019.

NLCP filed FCC Form 471 late because NLCP submitted Funding Year 2019 FCC Form 470 #190026585 on February 28th, just 2 days after the deadline to file FCC Form 471 after the Allowable Vendor Selection/Contract Date (ACD), which is 28 days after your FCC Form 470 is certified in the EPC. The reason for late filing Funding Year 2019 FCC Form 471 #191041619

was a USAC system error that occurred on February 21st, 2019 in which I clicked on the certification button and failed to understand the submission did not complete when the page changed to an error page. On February 28th, when I logged back into the system, I noticed that the Funding Year 2019 FCC Form 470 #190026585 was not listed as certified. In USAC Case # 267887, the system issue was documented. USAC indicated there was no other recourse but to certify Form 470 late in the EPC portal and file a FCC Appeal once the Form 471 was submitted and certified, after the allotted 28 day competitive bidding process.

II. REQUEST

NLCP respectfully petitions the Commission to request a wavier of the Funding Year 2019 FCC Form 471 filing deadline on behalf of NLCP to allow the Out of Window submission of their E-Rate Funding Year 2019 FCC Form 471 #191041619, due to the reasoning stated above.
