SUPPLEMENTAL FILING OF CHARTER COMMUNICATIONS, INC.

Charter Communications, Inc. (“Charter”) hereby notifies the Commission that it is providing on-channel carriage of KLEI-TV, Kailua Kona, Hawaii (“KLEI”) throughout all of its service areas in the State of Hawaii. As Charter explained in its Answer in this docket, Charter needed to relocate stations before completing Mauna Kea’s request for on-channel carriage of KLEI in Oahu and Kauai.¹ Charter has completed relocating the stations previously occupying the channels, and on-channel carriage of KLEI commenced in Oahu and Kauai on March 27, 2018.


