Dear Ms. Dortch:

Pursuant to Section 1.1206(b) of the Commission's Rules, 47 C.F.R. § 1.1206(b), notice is hereby provided of an oral *ex parte* communication in the above-captioned docket. On April 9, 2019, Ankur Kapoor, Vice President, Network Technology of T-Mobile US, Inc. ("T-Mobile"), Bryan Keating, Executive Vice President of Compass Lexecon, and other representatives of T-Mobile¹ had a telephone conversation with members of the FCC Transaction Team (a list of FCC participants is provided in Attachment A).

During the phone call, T-Mobile discussed the in-home broadband submission previously provided to the Commission.² In particular, T-Mobile discussed the various scenarios utilized to model traffic and build solutions in the baseline engineering model as well as other scenarios developed by Compass Lexecon. T-Mobile also discussed Document 10a, which was previously provided to the Commission and describes in detail the baseline network for the New T-Mobile 5G network.³
