MOTION FOR EXTENSION OF TIME

Comes now, Birach Broadcasting Corporation, ("BBC"), the licensee of Radio Stations WBVA (AM), Bayside, Virginia and WVAB (AM), Virginia Beach, Virginia, (the "Stations") by its counsel, hereby submits this Motion for Extension of Time in which to respond the Hearing Designation Order ("HDO") issued January 22, 2018 by the Commission pertaining to the Stations.

BBC is in active negotiations with Multicultural Media, Telecom and Internet Counsel ("MMTC") and the Audio Division Staff whereby BBC would donate the above captioned Stations to MMTC. MMTC is a 501(c)(3) and is well known to the Commission for its good works with introducing new minority ownership into the broadcasting landscape. After certain organizational delays, MMTC, has now been authorized by the Board of Directors of its broadcast subsidiary to accept donations of BBC's Stations.


An extension of two (2) weeks would provide BBC, MMTC and the Audio Division sufficient time to determine if the donation can be accomplished via an FCC Consent Decree. If such a Consent Decree can be agreed to, there would be no need for any further action on the HDO, thereby saving Commission Staff time and taxpayer dollars. This is not a contested proceeding and as such an extension will not be prejudicial in any way.

Under the circumstances, good cause exists for an extension of time for the submission of any documents by BBC in this this proceeding.

The foregoing premises considered, the instant Motion for Extension of Time should be granted.


