**Petition for Waiver of
FCC Filing Deadline for Request for Deadline Extension
RE: FCC Form 500 BEN 143567**

I. INTRODUCTION AND SUMMARY

The Burbank Unified School District ("Burbank") serves middle to low income pre-kindergarten through Grade 12 children in the city of Burbank, CA. Since 2001, "Burbank" has been a small but successful participant of the E-Rate program. The "Burbank" submitted an Implementation Deadline Extension Request for FCC Form 471 1028240, using FCC Form 500 Funding Commitment Adjustment Request Form submitted using the "Submit a Question" portal of the Schools and Libraries Division ("SLD") of the Universal Service Administrative Company's ("USAC") website, on January 11, 2018. We filed our Form 500, after the Implementation Deadline Extension Request filing deadline of September 30, 2017.

II. BACKGROUND

Our District was in the middle of implementing a variety of projects (E-Rate and non E-Rate local Bond work) at the same time. We only had one summer to complete this work and had multiple Service Substitutions and extensions pending for the various E-Rate funding years. We were managing the implementation of five FRNs covering 2 funding years through contract extensions and deadline extensions and service substitutions as project delays relating to our Bond implementation and approvals intruded on our installs. We released our Project Management Firm in September 2017 and was not advised of the need of an implementation deadline extension. In the Winter of 2017 we received an updated project plan directly from our Service Provider and the projected timeline went beyond the September 30, 2017 implementation deadline. The scope included products and services associated with our expired E-Rate funded application and we were not alerted to this prior to the deadline by our management team. Our extension request would have been approved if it had been filed timely (prior to the September 30, 2017 deadline) and we would have made sure the Form 500 filing was completed prior to the deadline had we been aware of the need for additional time. We immediately prepared and filed our implementation deadline using the FCC Form 500 (See Attachment A1). We received notification of review from USAC staff via email (See Attachment A2). Upon receipt, we replied to the reviewer's request for additional information (See Attachment A3). After consideration, USAC denied our request in full stating that the request had been filed after the deadline implementation deadline (See Attachment A4). We understand that USAC is unable to waive program rules where deadlines are concerned so we are seeking to appeal directly to the FCC for this consideration.

The Order and Order on Reconsideration reviewed 22 requests from petitioners seeking review of decisions made by USAC under the E-Rate program. One of these petitioners was seeking a waiver on the Implementation Deadline Request deadline. This request was granted for this petitioner. King George County Schools in Virginia was granted the waiver and the justification was based upon a decision for *"Request for Waiver by Jemez Pueblo Tribal Consortium; Schools and Libraries Universal Service Support Mechanism*, CC Docket No. 02-6, Order, DA 17-1179, at 4-6, paras. 7-11 (WCB Dec. 6, 2017), 2017 WL 6261543 (granting a waiver of the deadline to request an extension of the deadline to complete construction and use a self-provisioned network by the end of the funding year when the extension request would have been granted if it had been timely filed, the applicant made significant, good faith efforts to extend the implementation deadline, and there was no evidence of waste, fraud, or abuse)."





Good morning Allison,

Thank you for looking into this for us. Here's what's going on:

Our Service Provider was unable to deliver and install our products because the locations for installation were not made available on schedule due to facilities changes and construction delays. We have an implementation project going on throughout the district and we are using two separate providers to complete this work. One service provider is providing the hard-wired network infrastructure (cabling) which also includes cabinets, punch blocks and power and we are using the subject provider (Nexus IS) to provide and install the network electronics. When our cabling vendor experienced delays, it set back the timeline for all installations that followed. We had changes in the scope of work also due to facilities issues discovered during construction. The desired location for a number of the IDFs were not suitable because of construction (walls and materials) as well as distance limitations. This necessitated the network design changes, changes in location for the communications cabinets and new services being pulled and installed to those new locations. Since our provider has to follow the cabling installation, the delays caused them not to be able to install and configure the equipment within the implementation deadline.

Our cabling vendor is back on track and we expect the cabling infrastructure to be completed shortly. Nexus IS is ready to delivery and install our devices the moment the locations are ready. At that time, we'd like for Nexus IS to complete the delivery and installation of our network electronics. These delays were well out of the control of our provider and we need the additional time to have this network completed and available to our students and teachers.

After thorough review and investigation of all relevant facts, the Schools and Libraries Division ("SLD") of the Universal Service Administrative Company ("USAC") has made its decision in regard to your implementation extension request. This letter explains the basis of USAC's decision. The date of this letter begins the 60-day time period for appealing this decision.
