Fishers Island Telephone Corporation (Study Area Code 150095) hereby provides the FCC with notice of its intention to discontinue offering its DSL and Consumer Broadband-Only Loop (CBOL) broadband Internet transmission services as separate components of its broadband Internet access service, effective July 3, 2018. As such, the transmission components will not be provided as separate regulated services and will only be provided as part of the complete broadband Internet access service that the Company offers to its end user customers within its New York serving area.

The Company currently provides its DSL and Consumer Broadband-Only Loop (CBOL) broadband Internet transmission services pursuant to NECA Tariff FCC No. 5. The only customer for the Company's broadband Internet access transmission service is its affiliated nonregulated ISP operation. Notice to its affiliated ISP operation was provided on this date by interoffice memorandum that the Company will discontinue the offering of broadband Internet transmission service as a separate component of its broadband Internet access service, effective July 3, 2018.
