Description of Network Changes Planned:

On March 13, 2019, air pressurized copper feeder cable serving areas in the Miami Airport (MIAMFLAP) wire center sustained irreparable damage when water entered the pulp-insulated cable due to an air pressure failure. As a result, customers with service provisioned on the failed cable lost service.

Two distribution areas (DA), 440301 and 440302, were impacted by the damaged cable. AT&T Florida restored service by migrating affected customers' service to a different copper feeder cable, or an existing fiber solution where available. Consequently, the damaged copper cable has no working customers on it and will be retired.

Description of Reasonably Foreseeable Impact of the Planned Changes:

AT&T Florida has transferred customers with working services to other existing copper or fiber facilities in these DAs, so the copper retirement will not have an impact on AT&T Florida's ability to continue to provide wholesale or retail services over copper feeder cable in either DA 440301 or 440302.
