Dear Ms. Dortch and Federal Communications Commission,

As per requested I am sending in additional information concerning the health problems and issues that were and are continuing to affect my family.

My husband was diagnosed with prostate cancer in September 5th 2017 and had prostate surgery on September 26th for complete removal of his prostate. After that surgery, I drive him to his doctor for weekly checkups and PSA tests. Therapy treatments were also scheduled for twice a week and those are still on-going. My husband must also continue with PSA tests monthly to see that cancer has not returned or spread to other areas. As we live in Calhan, those trips to Colorado Springs take quite the toll on both my husband and myself. Just traveling to Colorado Springs takes almost an hour one way. My husband's urologist also suggested that we file paperwork to the VA as well as my husband was in Vietnam. That required additional trips to not only Colorado Springs but to Denver.

My health problems began in September 20th 2017 with my doctor asking that I see a hematology specialist as my red and white blood count was extremely low. She also asked that I see a skin specialist as well as I was getting lots of bruises on my skin. As I had to put my health on hold because of my husband's surgery and appointments, I began seeing my hematologist on December 11th. She requested further testing of x-rays, ultra-scans, CT scan and MRI. My ultra-scan was on December 15th. My CT scan was January 11th and my MRI on January 31st. That is when I found out I had several cysts on my pancreas. My hematologist and my primary care doctor set me up to see a gastrologist. I began seeing him on February 27th. He didn't like what he saw on the MRI, so he scheduled additional testing to remove cells from my pancreas to see if they were cancerous. That was just done on April 24th. Results are not completely in on that.

As you can see, there has been lots and lots of medical appointments, blood work, and tests with much to handle and still be of support for Frontier Charter as much as I could. I did a lot of my work in the evening and at home. I even tried several times at night to submit only to be kicked off because of internet not working or submission would freeze.

Thank you for your consideration in still approving this waiver. I truly apologize for the late entry.
