**REQUEST OF USA NETWORK FOR LIMITED WAIVER
OF VIDEO DESCRIPTION RULES**

NBCUniversal, LLC (“NBCUniversal”) hereby submits this request (“Request”) on behalf of its wholly owned non-broadcast programming network, USA Network (“USA” or the “Network”), pursuant to Section 1.3 of the Rules of the Federal Communications Commission (“FCC” or “Commission”),¹ for a limited waiver of the FCC’s video description rules subject to criteria that, if satisfied, would provide a safe harbor for USA and similarly situated networks.² This Request has the support of advocates for the blind and visually impaired.

As further detailed below, USA is a recognized industry leader in providing video-described programming for the benefit of blind and visually impaired viewers,

averaging well over a thousand hours of video-described programming per quarter.

The FCC's very restrictive repeat rule, however, allows only a small fraction of those hours to be credited in determining compliance with the quantitative requirements of the video description rules.³ This rule falls most heavily on networks, such as USA, that have developed a successful programming approach that combines repeats (including marathons) of the most popular television programming with newly produced programming. The success of this approach – and its high ratings among viewers – is evidenced by the consistent ranking of USA as the number one network among non-broadcast networks.

NBCUniversal understands and supports the purpose behind the repeat rule – to avoid creating both incentives for networks to repeat a small number of video-described episodes many times and disincentives to describe newly produced programming. The safe harbor approach proposed herein addresses both concerns through waiver criteria that set a very high threshold for both the *total number* of video-described hours (including repeats) and the *total percentage* of video-described newly produced non-live programming per quarter. Specifically, NBCUniversal requests that the Commission grant USA a limited waiver of the repeat rule for the period ending on June 30, 2021,⁴ as long as the Network airs at least *one thousand*

hours of described programming each quarter without regard to repeats and video-describes at least 75% of any newly produced non-live programming that is aired between the hours of 6:00 a.m. and midnight per quarter.⁵ NBCUniversal also urges the Commission to extend the waiver to any other top-five ranked non-broadcast network that meets these high thresholds during the waiver period.⁶

This Request satisfies the Commission’s public interest standard for waivers of the Commission’s rules.⁷ However, the safe harbor proposed herein is not intended to modify the waiver standard set forth in Paragraph 18 of the *2017 Order*.⁸ The special challenges presented by the current rules for networks like USA, as noted above, warrant a departure from the rules, and grant of the waiver will serve the public

interest.⁹ In particular, the waiver would create the right incentives for networks to increase their total quantity of described programming (both repeats and newly produced programs) and for this reason is supported by advocates for the blind and visually impaired representing the American Council of the Blind, National Federation of the Blind and the American Foundation for the Blind.

I. THE PROPOSED SAFE HARBOR CREATES THE RIGHT INCENTIVES TO OFFER MORE VIDEO-DESCRIBED PROGRAMMING

The Twenty-First Century Communications and Video Accessibility Act of 2010 (“CVAA”) and the FCC’s implementing rules originally required that multichannel video programming distributors with 50,000 or more subscribers provide 50 hours per calendar quarter of video-described prime time and/or children’s programming on each of the top five non-broadcast networks they carry.¹⁰ The top five networks are those with the largest national audience share during prime time hours, as determined by The Nielsen Company (“Nielsen”). The Commission updates this ranking every three years to account for changes in Nielsen’s ratings.¹¹ The most recent update became effective on July 1, 2018, resulting from the ratings for the time period October 2016 through September 2017.¹² According to Nielsen, USA ranks in the top five non-

broadcast networks for the current compliance window and has consistently maintained this status since the Commission reinstated the video description rules in 2011.

Pursuant to the *2017 Order*, as of July 1, 2018, affected distributors must provide an *additional* 37.5 hours of described programming during the hours of 6:00 a.m. through midnight, for an expanded minimum of 87.5 hours of described programming per quarter. Although the rules impose this obligation on the distributors, the programming networks actually procure and supply the video description in the secondary audio programming channel of the programming services provided to distributors. NBCUniversal recognizes that a gap remains between the scope of captioned programming for the deaf and hard of hearing compared to the amount of video-described programming for the blind and visually impaired and therefore fully supports the increase in the quarterly requirement for video-described hours by covered non-broadcast networks.

However, as detailed in NCTA's Petition for Partial Reconsideration of the *2017 Order* currently pending before the Commission,¹³ the video description rules permit affected networks such as USA to count only a small fraction of eligible hours for compliance purposes – specifically, the first airing of a described episode and *one repeat* of that episode.¹⁴ This severe restriction on the number of eligible

video-described hours presents special challenges for networks, such as USA, that do not air regularly scheduled children's programming and that build their programming schedules on a combination of repeats and new programming. For that reason, NCTA proposed several adjustments to the Commission's rules, including adoption of "a safe harbor so that a network that is unable to provide 87.5 hours of 'countable' video-described programming in a particular calendar quarter would still be considered in compliance if it otherwise provides a substantial amount of video-described programming."¹⁵

Nonetheless, NBCUniversal appreciates that advocates for the blind and visually impaired do not want to lose ground in their ongoing efforts to expand the accessibility of video programming to their constituents by weakening the repeat rule. Accordingly, NBCUniversal has focused on developing a limited waiver approach that creates strong incentives for USA and similarly situated networks to video-describe the majority of their newly produced non-live programming, while recognizing the public interest benefit of offering a very large number of video-described programming hours overall.

USA's position as a top-rated network is largely attributable to its programming approach, which involves airing repeat episodes (including marathons) throughout its schedule of highly popular acquired program titles, such as Law & Order, NCIS and Modern Family, along with newly produced series and some live sports programming

during prime time windows. The Network's programming model responds to viewer demand, and its success – as demonstrated by its consistent top-five ranking – has allowed USA to develop and launch original new series during prime-time programming, including *Suits*, *Mr. Robot*, *The Sinner*, *Chrisley Knows Best*, *Colony*, *Shooter*, and *The Cromarties*, all of which are also video-described.¹⁶

Since the NCTA Petition was filed, the Network has had multiple discussions with advocates for the blind and visually impaired representing the American Council of the Blind, National Federation of the Blind, and the American Foundation for the Blind, seeking their input on this Request to help meet the needs of viewers, networks and distributors. Throughout these discussions, the advocates emphasized the importance of both the overall quantity of video-described programming and creating incentives to video-describe newly produced programming.

Based on these discussions, NBCUniversal developed the limited waiver approach proposed herein, which has the support of the advocates. The Network and advocates agree that the Request, if granted, would create the right incentives to encourage USA and similarly situated programmers to expand their video-described hours without disruption to the top-rated non-broadcast networks' established and successful business models. The proposed waiver criteria also respond to Commissioner O'Rielly's recommendation in his

concurrence to the *2017 Order* that “the Commission should be adopting a real safe harbor, as opposed to [the case-by-case waiver approach adopted in the *2017 Order*], to provide certainty for programmers with business models that deviate from a standard mixture of original, live, and repeat content.”¹⁷

II. USA NETWORK MEETS (AND OFTEN EXCEEDS) THE PROPOSED SAFE HARBOR THRESHOLDS

In preparing this Request, NBCUniversal reviewed USA’s programming line-ups for a total of four quarters, from January 1, 2018, through December 31, 2018. For each quarter during this period, NBCUniversal identified the Network’s total described programming hours without regard to repeats as well as the total hours of described original programming aired between the hours of 6:00 a.m. and 11:59 p.m. (ET) that is not “live or near-live,” as defined by the FCC.¹⁸ Based on this review, and as further detailed in the attached affidavit, NBCUniversal determined that over this four-quarter period, USA averaged more than 1,600 hours of described programming each quarter without regard to repeats and described approximately 78% of any newly produced, non-live quarterly programming that was aired between the hours of 6:00 a.m. and midnight (ET). The table set forth below and in the attached affidavit provides a quarter-by-quarter analysis of video-described programming on USA throughout 2018:

In further support of this Request, attached is a video description report from the month of February 2019, which provides additional details with respect to USA’s extensive video-described programming lineup offered throughout each day, seven days a week. Specifically, the report indicates that of the 535 hours of described programming that the Network aired that month, only 25 hours – less than five percent – were eligible under the current video description rules.

CONCLUSION

As demonstrated herein, USA is well established as a leader among non-broadcast networks in offering video-described programming and has demonstrated a commitment to providing an ever-expanding library of described televised content, including the majority of its non-live newly produced programming. Accordingly, NBCUniversal respectfully asks the Commission to grant the instant Request for a limited waiver of the Commission’s video description rules for the remainder of the

current three-year compliance period. NBCUniversal also urges the Commission to extend the waiver, if granted, to any network that meets the criteria proposed herein.

AFFIDAVIT OF ANGELA Y. BALL

I, Angela Y. Ball, serve as Senior Counsel for NBCUniversal. In this capacity, I asked NBCUniversal employees with USA Network (“USA” or “the Network”) programming responsibilities to review the Network’s grids for a total of four quarters (from January 1, 2018, through December 31, 2018) to determine (1) the total number of described programming scheduled for broadcast by USA without regard to repeats and (2) the percentage of non-live (i.e., neither live nor near-live) original programming for which the Network offers video description between the hours of 6:00 a.m. to 11:59 p.m. (ET) during this period. Based on this review of USA’s grids, the Network annually averaged over 1,600 hours of video-described programming and described over 77% of any newly produced, non-live programming aired between the hours of 6:00 a.m. and midnight per quarter.


NBCUniversal’s analysis found that the number of total described hours of programming without regard to repeats during this period ranged from 1,587 hours per quarter to 1,711.75 hours per quarter, from which an average of 1,655 hours was calculated. For example, during the second quarter of 2018, USA described 1,636.5 hours, or 74.9% of the total 2,184 broadcast hours. Additionally, NBCUniversal’s findings indicated that the percentage of video-described non-live original programming airing between the hours of 6:00 a.m. and midnight ranged from 72.6%¹ to 87.8% per quarter, from which an average of 77.7% was calculated.
