RE: CC Docket No. 02-6; Request for Waiver

On behalf of Prestonwood Christian Academy (BEN 17012313), VST Services, LP hereby requests a waiver of the Funding Year 2019 471 filing window for Application #191042050, certified on April 10, 2019.

The Federal Communications Commission has established precedent in multiple orders (*Acorn Public Library District Order*,¹ *Academy of Math and Science Order*,² *Anderson Elementary School Order*³) that applicants that filed their 471 applications within 14 days of the 471 filing deadline have filed their applications close enough to the filing window that their applications should be considered timely submitted. In the *Academy of Math and Science Order*, the Commission found that applicants that filed their applications within 14 days of the deadline for filing had satisfied the Commission's requirement to show special circumstances.⁴ The Commission also found that applications that were filed within 14 days were filed close enough to the deadline so as not to impair the administration of the program.⁵

Prestonwood Christian Academy filed its 471 application on April 10, 2019, which was within 14 days of the filing window deadline of March 27, 2019. See attached FCC Form 471
