It is my first time working with a group of schools as a consortium, and I could have done a better job replying to USAC reviewer.

That being said, this is my humble appeal.

In working with all the other 471 Forms for our 14 schools. A few mistakes on my part leads me to be at this point.

Although I provided many of the reviewers request, I failed to provide all of the information to the USAC reviewer for our Form 471 #171046237.

My second mistake, I failed to request additional time from USAC to provide the required information for both Forms 471 # 171042942 and Form 471 #171046237 and the funding was denied in full for both forms.

My third mistake, I filed an Appeal #82298 immediately after the denial, on November 3, 2017. In my narrative I included both Forms #171042942 and #From 171046237 and thought this would include both forms.

The reviewer of the appeal was very helpful and guided my on correcting form #171042942 which I did. When I asked him about the other form #171046237, he explained to me that although I had it in the narrative, it was not entered as a separate Form. I called USAC on March 29, 2018 and explained the situation, and they instructed me to file another appeal with the missing Form #171046237.

I did so with Appeal # 92131 on March 29, 2018. I received notification yesterday, the appeal had past the 60 day window, and funding was denied. I called USAC yesterday, and explained the situation, they have instructed me to file an appeal with the FCC.

I am at this point,

The form #1710462237 is a request for much needed Category 2 schools technology upgrades. Two of the schools St. Catherine's serving 152 students and St. Rafael serving 455 students are Community Eligible School where all students are from low income families and are eligible to receive free breakfast and lunches.

Attach is a copy of our form 471 #171046237, I do believe the only thing I needed to do for this form to be awarded funds was to revise the budget numbers.
