Pursuant to Section 1.1206(b) of the Commission's Rules, 47 C.F.R. § 1.1206(b), notice is hereby provided of an oral *ex parte* presentation in the above-referenced docket. On May 10, 2019, David Miller, General Counsel of T-Mobile US, Inc. ("T-Mobile"), Kathleen Ham, Senior Vice President, Government Affairs of T-Mobile, Vonya McCann, Senior Vice President-Government Affairs of Sprint Corporation ("Sprint," and collectively with T-Mobile, "Applicants"), and other representatives of the Applicants¹ met with members of the T-Mobile/Sprint Transaction Team identified in Attachment A. During the meeting, the representatives of the Applicants reviewed in detail their plans for deployment of New T-Mobile's proposed in-home broadband service, as described in various filings previously submitted in this docket. In particular, the representatives discussed how the network build plan creates the opportunity for launching the in-home service and the planned Supported Households that will be achieved by the build plan. They also discussed how New T-Mobile plans to market the service and attract customers from incumbent providers.
