Dear Ms. Dortch,

On May 14, 2018, FirstDigital Communications, LLC, FirstDigital Communications Arizona, LLC, and FirstDigital Telecom Arizona, LLC (collectively, “FirstDigital”) and CenturyLink, Inc., filed a Joint Application for Consent to Assignment of Assets (“Joint Application”), which was assigned the above-referenced docket.

The Joint Application stated that, upon consummation of the transaction that is the subject of the Joint Application, FirstDigital will be able to expand into a market it does not currently serve, the Tucson Metropolitan Statistical Area (“MSA”). The purpose of this letter is to clarify that FirstDigital currently provides telecommunications services only in Utah, Idaho, and Arizona; however, with respect to Arizona, FirstDigital does not serve customers in the Tucson MSA.

The Joint Applicants also take this opportunity to clarify that no FirstDigital entities or any 10 percent or greater interest holder in such an entity has an affiliate that provides telecommunications services.

Lastly, for the sake of completeness, FirstDigital identifies below the name and citizenship of the general partners that control the Kem C. Gardner Family Partnership, Ltd., and the H. Roger Boyer Family Partnership Ltd., respectively, as identified on pages 14-16 of the Joint Application.
