

Farmers Mutual Cooperative Telephone Company (Defiance), Farmers Mutual Cooperative Telephone Company (Manilla) and Farmers Mutual Cooperative Telephone Company ("Companies") are providing notice pursuant to *Rate-of-Return Business Data Services Order* of the intent of the Companies to discontinue offering Packet-Based and Higher Capacity TDM Services as tariffed services effective July 2, 2019. The Companies are rate-of-return authorized Alternative Connect America Model carriers eligible to elect incentive regulation for BDS and previously provided notification to the Commission of such election.


