REQUEST FOR EXPEDITED ACTION

New Wavo Communication Group, Inc. (New Wavo), permittee of new FM station KVST(FM), Channel 278A, Huntsville, Texas, by its attorneys, hereby respectfully requests expedited action in the above-referenced proceeding. In support whereof, the following is submitted:

New Wavo was the original proponent of the Commission's proposal to substitute Channel 279C3 for Channel 278A at Huntsville, Texas, and modify KVST(FM)'s construction permit and/or license to specify operation on 279C3. New Wavo filed comments in the above-captioned proceeding on July 2, 1992, supporting the Commission's proposal. New Wavo also submitted a Statement for the Record on July 27, 1992, indicating that it was not aware of any other comments filed by any other parties in the above-captioned proceeding.

Pursuant to the Notice of Proposed Rulemaking in the above-captioned proceeding, interested parties were to have filed

comments on or before July 13, 1992, and reply comments on or before July 28, 1992. As the attached copy of the Record Index Data in this proceeding indicates, the only party that filed anything in this proceeding as of July 31, 1992, was New Wavo. No other party has indicated any interest in or concern about the Commission's proposal in this proceeding.

Rather than delay the initiation of service to Huntsville while it sought an upgrade, New Wavo constructed and placed KVST on the air before it sought the upgrade. However, the economic viability of KVST(FM) is dependent upon the outcome of this proceeding and the ability of KVST(FM) to improve its facilities as proposed. Since the proposal is unopposed, New Wavo requests expedited action so that it can proceed to prepare and file its application as soon as possible. Accordingly, New Wavo requests that a Report and Order amending the Commission's Rules as proposed and terminating this proceeding be expeditiously prepared, adopted, and released.
