

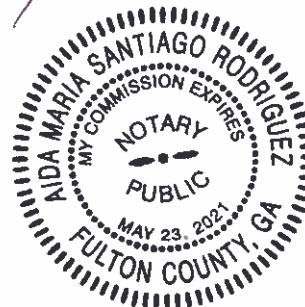


**WITHDRAWAL OF APPLICATION**
