Because of an earlier system issue preventing correspondence between the applicant and reviewer for this application, this request for information has been sent to you via an external email server as well as EPC. Issue

USAC's Program Integrity Assurance (PIA) team is currently reviewing your FCC Form 471 application, and we have identified an issue that we need you to help us resolve. What is the issue?

- 1) On your form, the Category Two budget for POWER CENTER ACADEMY ELEMENTARY - #16050141 is \$56,850.00, but the Category Two funding requested for this entity is \$119,380.43. This is an issue because the entity's Category Two funding requests exceeds its budget by \$62,530.43;
 - 2) On your form, the Category Two budget for KLONDIKE PREPARATORY ACADEMY - #16074252 is \$45,600.00, but the Category Two funding requested for this entity is \$118,059.71. This is an issue because the entity's Category Two funding requests exceeds its budget by \$72,459.71;
 - 3) On your form, the Category Two budget for HUMES PREPARATORY ACADEMY - #16074253 is \$63,150.00, but the Category Two funding requested for this entity is \$133,352.64. This is an issue because the entity's Category Two funding requests exceeds its budget by \$70,202.64;
 - 4) On your form, the Category Two budget for POWER CENTER ACADEMY MIDDLE - #16084392 is \$9,200.00, but the Category Two funding requested for this entity is \$182,071.99. This is an issue because the entity's Category Two funding requests exceeds its budget by \$172,871.99;
 - 5) On your form, the Category Two budget for NEXUS STEM ACADEMY MIDDLE SCHOOL - #17006988 is \$9,200.00, but the Category Two funding requested for this entity is \$44,290.60. This is an issue because the entity's Category Two funding requests exceeds its budget by \$35,090.60; and

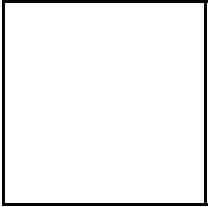
