Hi Tiana,

Thank you so much for your support. Not only will this help Omar D Blair, but I believe this will also help your company. I'm not sure how familiar you are with E-rate; it's a federal program that provides reimbursements to schools and libraries for network equipment and service purchases. Schools in the Denver metro area, depending on their district, receive between 50% and 80% reimbursements. E-rate has a specific bidding site that, once you as a company are signed into the bidding site, you can see all the bid opportunities and participate as you like (note: the bidding window just closed, but I'll show you how to search bids once the window opens up again next January)

E-rate has a particular timetable; we're a little past the deadline for Omar D Blair but if you and I can work together to get this set up ASAP, I believe we can still file a waiver so that Omar D Blair can receive a reimbursement for your work. Here's what you need to set up an account

- Your EIN
- Your DUNS number (if you don't have one, get one here:  
<https://www.dandb.com/product/companyupdate/companyupdateLogin?execution=e1s1>)
- Your FCC Registration number (if you don't have one, get it here:  
<https://apps.fcc.gov/coresWeb/publicHome.do>)
- Fill out Form 498 for the Universal Service Administrative Company (USAC) online here:  
<https://efile.universalservice.org/ServiceProvider/V1>
  - USAC is the organization that administers e-rate

Once this is done, you will be provided a Service Provider Identification Number (SPIN) ... send that number to me as soon as you can.

Also, once this is done, call USAC's help desk at [888-641-8722](tel:888-641-8722) to set up your login credentials for their portal, called EPC (pronounced "epic").

Once your login is created, you can I can set up a time where we can share screens and I can walk you through how to search for bids next January

Keep in mind that this cabling work cannot begin or get paid for until after July 1<sup>st</sup>. Please let me know if you have any questions. Thank you!
