Pursuant to the *Wireline Broadband Order*¹, Clarence Telephone Company (CTC), files the enclosed notice of its intent to discontinue its wireline broadband access service and Consumer Broadband Only Loop (CBOL) service offering under NECA Tariff No. 5 effective July 1, 2017. CTC will provide Digital Subscriber Line Service and CBOL service on a de-tariffed common carrier basis effective July 1, 2017.

CTC has notified its current affected customers per the attached memo dated May 5, 2017. The geographic area CTC serves is the town of Clarence in Iowa and the nearby areas outside of the town within its own telephone exchange. There will be no significant change to its customers with CTC's choice to de-tariff its DSL and CBOL services as the provisioning of these services will not be affected by this decision. Effective July 1, 2017, the terms and conditions under which DSL and CBOL will be offered by CTC will be posted for public inspection on its website at www.clarencetelinc.com and a physical copy of the offerings will be available at its office, located at 608 Lombard Street, Clarence, IA 52216.

Effective July 1, 2017, CCC will no longer participate in NECA Tariff No. 5, for Digital Subscriber Line Access Service and Consumer Broadband Only Loop Service. However, the services will be offered on a de-tariffed Title II Common Carrier basis.
