On May 29, 2019, the undersigned, as counsel for a coalition¹ that will be filing comments in the above-captioned docket, met with Will Adams, Legal Advisor to Commissioner Carr and Umair Javed, Legal Advisor to Commissioner Rosenworcel.

Our conversations focused on how the FCC's proposal went far beyond the original intent and delegation of authority to the Commission pursuant to Section 207 of the Telecommunications Act.
