Pursuant to the *Wireline Broadband Order*¹, Mediapolis Telephone Company d/b/a MTC Technologies, files the enclosed notice of its intent to discontinue its wireline broadband access service offering under NECA Tariff No. 5 effective July 2, 2019. MTC will provide Digital Subscriber Line Service on a de-tariffed common carrier basis effective July 2, 2019.

MTC has notified its current affected customers per the attached memo dated May 14, 2019. The geographic area MTC serves includes the towns of Mediapolis, Kingston, and Dodgeville and surrounding areas of its own telephone exchanges. There will be no significant change to its customers with MTC's choice to de-tariff its DSL service as the provisioning of the service will not be affected by this decision. Effective July 2, 2019, the terms and conditions under which DSL will be offered by MTC will be posted for public inspection on its website at <http://www.mtcotech.net/> and a physical copy of the offerings will be available at its office, located at 652 Main Street, PO Box 398, Mediapolis, IA 52637.

No action is necessary on your part. This is an informational notice as required by the Federal Communications Commission (FCC) that Mediapolis Telephone Company d/b/a MTC Technologies will discontinue providing Digital Subscriber Line (DSL) Access Service on a tariffed basis. Effective July 2, 2019, MTC will no longer participate in NECA Tariff No. 5 for DSL Access Service and instead will offer the service on a de-tariffed Title II Common Carrier basis.

MTC serves the towns of Mediapolis, Kingston, and Dodgeville and surrounding areas in Iowa within its exchange boundaries. The provisioning of services for your current DSL Access Service is not changing.
