I would like to extend my support for of WCJB TV20's market modification petition to allow local broadcasts from this station to Marion County.

WCJB is a local station that reaches Marion County via cable and over the air antenna. I ask that satellite viewers be given the same opportunity as cable subscribers to access important information provided by our local station. Adding WCJB to the satellite companies will allow Marion County residents to view Live Local community news, weather, sports and Emergency information which is already being reported on by WCJB daily. WCJB is the only broadcast station with a full-service news bureau in Marion County. Unfortunately, satellite viewers living in Marion County cannot receive vital local news and weather updates, and they are forced to rely on these updates from Orlando sources until the WCJB petition is granted.

For these reasons, I ask the Federal Communications Commission work with the parties to grant these petitions. 
Dear Congressman Yoho:
