This letter is written on behalf of Skyride Unlimited, Incorporated ("Skyride"), which was formerly the applicant for authority to construct and operate a new noncommercial, educational FM station on Channel 215B to serve Shafter, California (FCC File No. BPED-901004MM). On August 19, 1992, the Commission released the Hearing Designation Order in the above-referenced proceeding, and set for a comparative hearing the application filed by Skyride and those submitted by Family Stations, Inc. (FCC File No. BPED-890815MC) and Shepherd Communications, Inc. (FCC File No. BPED-891113ME). This Hearing Designation Order was adopted by the staff on August 5, 1992.

As the Commission has been previously advised, Skyride acquired the construction permit for noncommercial, educational FM Station KAXL(FM), Greenacres, California, pursuant to the authority of FCC File No. BAPED-910502HF, on August 14, 1992. A condition imposed by the Commission upon the grant of that authority required that Skyride dismiss its application for the station on Channel 215B at Shafter, and, accordingly, a request for dismissal of that application was filed with the Commission on August 17, 1992 (a copy of which is enclosed). Because this request was filed following the adoption of the Hearing Designation Order, but before its release, Skyride is submitting this letter to make it clear that, inasmuch as it has dismissed its Shafter proposal as required


