Description of Network Changes Planned:

BellSouth Telecommunications LLC d/b/a AT&T Florida intends to retire and remove copper feeder facilities in the Riviera Beach Wire Center (WPBHFLRB- 3640 AVENUE E RIVIERA BEACH FL 33404). A Florida Inland Navigational District (FIND) Dredging Project is in conflict with the existing cable crossing the Intra-Coastal waterway. In DAs 230503 and 230902, 11.4KF submarine/buried feeder copper cable will be retired. Both DAs will be served via fiber feed Digital Loop Carrier Systems. Working copper facilities will be cutover to the existing universal DLC systems at both DAs 230503 and 230920.

Description of Reasonably Foreseeable Impact of the Planned Changes:

After this plan is completed all copper Feeder facilities will no longer be available within DAs 230503 and 230902. After the retirement of the Copper facilities, AT&T Florida will: (1) no longer offer DSL services over the DLC to Competitive LECs; and (2) cease maintaining the copper Feeder facilities. Currently, there are no Competitive Carrier circuit of this type on the affected copper facilities.
