**MOTION TO WITHDRAW PETITION FOR CLARIFICATION
OR DECLARATORY RULING**

ContextMedia, Inc. d/b/a Outcome Health (“Outcome”) hereby submits for the consideration of the Federal Communications Commission (“Commission”) the instant motion to withdraw the above-referenced petition in CG Docket No. 02-278.¹

By way of background, the Petition asserts that Outcome did not violate the Telephone Consumer Protection Act (“TCPA”) or the Commission’s rules, and that the Commission’s implementation of the TCPA has never been intended to penalize good-faith compliance with the agency’s rules. Among other issues, the Petition notes the rise in TCPA-related liability suits and reported that Outcome was defending against a putative class action in the District Court for the Northern District of Illinois (“District Court”).²

Outcome hereby advises the Commission that the parties recently entered into a Settlement Agreement and Release, which will resolve the class action. Given that the District Court has granted preliminary approval of the class settlement,³ Outcome hereby respectfully requests that the Commission allow Outcome to withdraw its Petition and dismiss DA 17-1054.
