Dear Ms. Dortch,

On June 16, 2016, CTIA and representatives from member companies met with staff from the Wireless Telecommunications Bureau, Office of Engineering and Technology, and International Bureau to discuss the above-referenced proceedings. A list of meeting attendees is attached.

During the meeting, CTIA and members reiterated their support for the Commission moving forward this summer to make the 28, 37, 39, and 64-71 GHz bands available to support innovative 5G and Internet of Things technologies. CTIA also urged the Commission to adopt a framework for licensing and service rules that is grounded in the long-standing, highly successful principles of exclusive spectrum use and flexibility, which will provide the certainty licensees need to invest in these bands. Given the importance of these bands to support next-generation wireless products and services, as well as the nascence of the technologies at issue, the Commission should not undermine innovation by adopting unproven sharing frameworks for these bands. Such regulatory experiments have the potential to introduce uncertainty and prevent licensees from using their spectrum when and where they need it.
