Dear Ms. Dortch:

Following discussions with Federal Communications Commission (“Commission”) staff, Horry Telephone Cooperative, Inc. (“HTC”), by its counsel, hereby submits this letter to request that the Commission update its Universal Licensing System (“ULS”) database and remove the partitioned area of Horry County (listed as C45051)¹ from the list of licenses available in Auction 101. That area, while previously partitioned, is now part of license WPOH936 and held by HTC.

WPOH936 (originally an A block LMDS license) originally covered all of BTA 312 (including the Myrtle Beach area). In 1999, HTC requested the Commission to partition the license so that it could assign a portion of it, which covered Myrtle Beach, SC, to West Carolina

Rural Telephone Company ("West Carolina").² The Commission granted the requested partition and issued a new license, call sign WPOL288, for the Myrtle Beach, SC area to West Carolina. In 2001, when West Carolina decided it no longer needed the new license, it assigned the partitioned license WPOL288 back to HTC.³ In 2014, in response to a request from Commission staff, HTC submitted a modification to the Commission, requesting that the Commission combine the licenses, WPOL288 and WPOH936, into one contiguous geographic area.⁴ After the modification application combining the licenses was granted, HTC then canceled WPOL288.⁵

For the foregoing reasons, C45051 should not be listed as a license available for bidding in Auction 101. HTC respectfully requests that the Commission remove that license from the list and issue HTC the Upper Microwave Fixed Use Service license for that area that should properly be associated with the conversion of its WPOH938 LMDS license.
