Dear Ms. Dortch:

Pursuant to Section 51.325 – 51.335 of the Commission's rules, Kearsarge Telephone Company ("KTC") hereby submits the attached: Certification of Public Notice of Network Change under rule 51.329(a); Public Notice of Copper Retirement under rule 51.333; and Certification of Public Notice of Copper Retirement under rule 51.333. Specifically, KTC is providing notification of the replacement of copper distribution and loop facilities with fiber-to-the-home facilities in certain digital service areas (DSA) located in Boscawen, New London, Salisbury, and Wilmot NH. Upon completion, KTC will provide services through its fiber optic network.

All of the customers served by copper at these locations purchase "plain old telephone service" (POTS). Following transition to fiber, KTC will continue to offer these customers the same POTS service over fiber at the same or better price as they received on copper facilities. There will be no change in the underlying features and functionalities in their service: this is not a transition to IP-based service, and KTC will offer these customers the same regulated service they have today.

**Description of the Planned Network Change(s):**
