**Certification of Number of Subscribers
by Liberty Cablevision of Puerto Rico LLC
for Stage 1 Funding**

Liberty Cablevision of Puerto Rico LLC (“LCPR”) is a facilities-based provider in Puerto Rico. LCPR certifies that it provided voice or broadband Internet access service in Puerto Rico as of June 30, 2017 to 340,472 subscribers comprised of the following: 330,482 subscribers to broadband Internet access service and 9,990 VoIP subscribers, who did not also receive broadband Internet access service. LCPR submits as Exhibit 1 a redacted copy of LCPR’s Form 477 Filing for the relevant time period.

LCPR confirms its willingness to be designated as an eligible telecommunications carrier (“ETC”) and has submitted its ETC application to the Puerto Rico Telecommunications Regulatory Board. LCPR is committed to rebuilding a modern, resilient communications network throughout Puerto Rico after the devastation and destruction caused by Hurricanes Irma and Maria. LCPR seeks

to participate fully in the Stage 1 Funding for Immediate Restoration and appreciates the Commission's concern for, and commitment to, Puerto Rico and the expeditious action which it is pursuing.

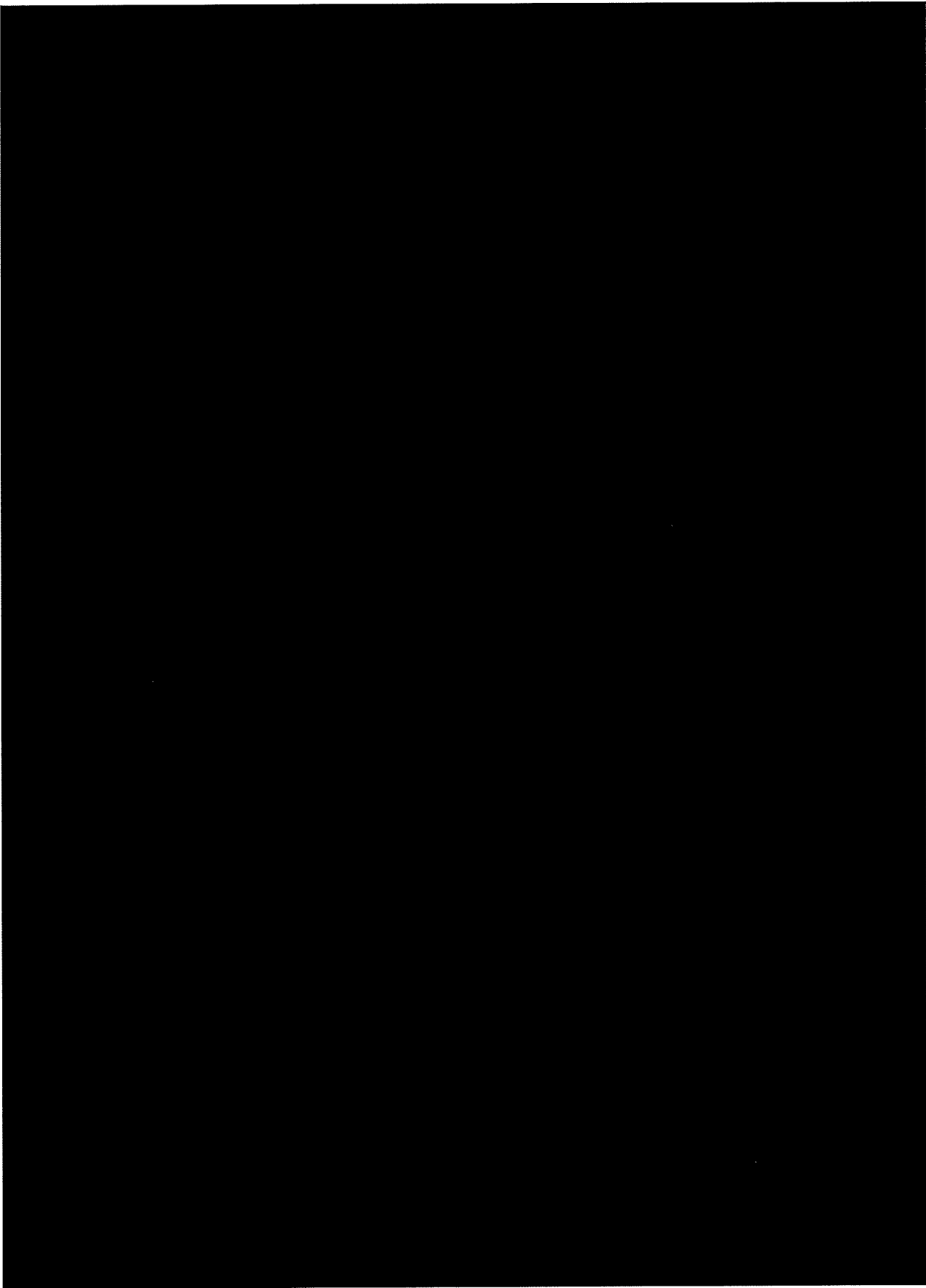
Census Block Counts by State, DBA Name and Technology

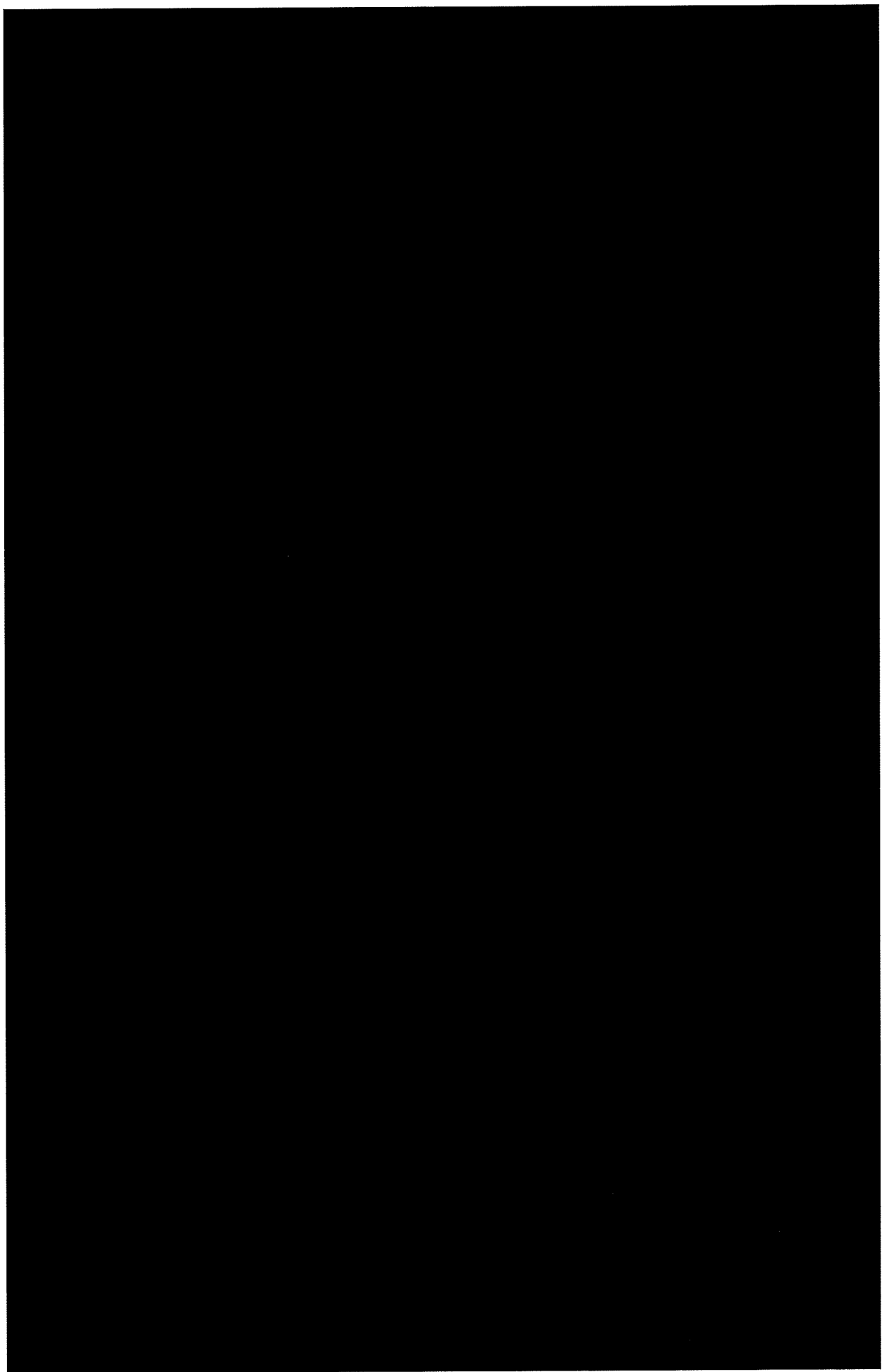
