**SECTION 63.71 APPLICATION OF
TDS METROCOM, LLC**

TDS Metrocom, LLC ("Applicant") seeks authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. §214(a) and Section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue its provision of all Voice and Data services to a limited number of customers at various addresses in the Battle Creek and Plymouth, Michigan Market Areas. The Applicant provides the following information pursuant to Section 63.71 of the Commission's Rules:

1. Name and Address of the Carrier: TDS Metrocom, LLC, 525 Junction Road, Madison, Wisconsin 53717.
2. Date of Planned Service Discontinuance: Applicant plans to discontinue the affected services on September 3, 2019.
3. Points of Geographic Areas of Service Affected: Applicant proposes to discontinue the affected services to certain customers in the Battle Creek and Plymouth, Michigan Market Areas. Services provided to these existing residential and commercial customers will be discontinued and services will no longer be offered to new customers following the proposed discontinuance.
4. Description of Service Affected and Reason for Discontinuance: The services to be affected are all voice and data services. The services are being discontinued because it is not economically viable for the Applicant to continue to offer service.
5. Brief Description of the Dates and Methods of Notice to All Affected Customers: Applicant mailed a written notification of the planned discontinuance to the impacted customers utilizing the services in accordance with Section 63.71(a) of the Commission's Rules. Customer notifications were mailed via first-class U.S. Postal mail on June 4, 2019. A copy of the notification is attached to this application.

6. Regulatory Classification of Carrier: Applicant is considered non-dominant with respect to the services to be discontinued.

7. Other Information: In accordance with Section 63.71(a) of the Commission's Rules, a copy of this application is being mailed concurrently with its filing to the state regulatory commission and governors' office, as well as to the Department of Defense. Please direct questions regarding this application to the undersigned.

Conclusion: The public convenience and necessity will not be adversely affected by the discontinuance of the services described herein. Advance notice has been provided to all affected customers giving them ample time to arrange for substitute services readily available from other providers. Therefore, Applicant respectfully requests that the Commission approve this Section 63.71 application.
