As directed in the Federal Communications Commission's *Hurricane Relief Order*,¹ attached please find certifications regarding the subscriber counts as of June 30, 2017 for the following entities:

- Virgin Islands Telephone Corporation d/b/a Viya (Form 499 Filer ID 803418)
- Vitelcom Cellular, Inc., d/b/a Viya Wireless (Form 499 Filer ID 812429)
- Choice Communications, LLC (Form 499 Filer ID 815426)

Consistent with the direction of staff, these certifications indicate that subscriber counts reported in the three companies' June 2017 Form 477 filings are accurate. In the event that additional information is required, the companies are happy to provide it.

Consistent with the requirement in the *Hurricane Relief Order*,² Viya and Choice already are certified as high-cost eligible telecommunications carriers ("ETCs") by the Virgin Islands Public Services Commission ("PSC"). Viya Wireless is certified as a Lifeline ETC, and submitted an application to the PSC on June 7, 2018, to modify its ETC designation to include eligibility for the Connect USVI program.




