**MOTION FOR EXTENSION OF TIME**

Frontier Communications Corporation (“Frontier”) submits the following Motion for Extension of Time. Specifically, Frontier respectfully requests a limited extension of the July 1, 2016, deadline<sup>1</sup> for Frontier to revise its FCC Nos. 13 and 14 National Discount Plan (“NDP”). While Frontier will file its updates to all other plans affected by the Tariff Investigation on or before July 1, 2016,<sup>2</sup> Frontier requests an extension until July 15, 2016 to file the revisions related to the NDP.

Frontier requests this limited extension in order to provide additional background information related to how its proposed updates to the NDP would affect existing and potential customers. In particular, due to limited customer enrollment, limited customer demand, and complexity associated with administering the plan, Frontier plans to grandfather the NDP, allowing existing customers to continue subscribing to the plan and closing the plan to new customers. Potential customers have not indicated any interest in this plan, and Frontier only has two customers on the NDP (one of which subscribes to fewer than five circuits under the plan).

Frontier only just acquired the NDP from Verizon in April of this year and would otherwise be looking to grandfather this plan due to the significant complexity associated with administering it. Frontier previously grandfathered a version of this plan covering other properties it acquired from Verizon in 2010.<sup>3</sup>

With a modest amount of additional time, Frontier will be able to provide additional information associated with this plan and its proposed revisions. Accordingly, Frontier requests an extension until July 15, 2016, for filing its revisions to the NDP.
