ABRAHAMIAN REPORTS HE HAS NO KNOWLEDGE OF KRAWCZYK DOING ANYTHING ILLEGAL BUT IS UNSURE AS TO WHETHER OR NOT SHE HAS ANY PERSONAL INFORMATION OR HIS SOCIAL SECURITY NUMBER WITH WHICH HIS IDENTITY COULD BE ATTACKED. ABRAHAMIAN WAS INFORMED THAT A POLICE INFORMATION REPORT WOULD BE FILED AND THAT IF HIS CONCERN WAS SO GREAT, HE SHOULD CONTACT A COMMERCIAL IDENTITY PROTECTION COMPANY FOR HIS FINANCIAL SAFETY.
