Back-up Power for Both Voice and Broadband Services

American Samoa Telecommunications Authority Interexchange Carrier Division (ASTCA IXC) updates and maintains equipment to prevent outages before they happen. If outages do happen, the Company has 24-hour on call staff and alarm reporting systems in place that send notifications to the 24 hour personnel monitoring these systems. ASTCA IXC certifies that it follows best practices that are designed to allow them to remain functional in an emergency situation through the use of back-up power to ensure functionality in the event of a limited commercial power failure.

ASTCA IXC utilizes battery back-up systems and standby generators in its switch locations and central offices. The following attachment is a list of equipment that enables ASTCA IXC to maintain power during an outage and in emergency situations.
