Dear Ms. Dortch:

On June 19, 2017, representatives of CenturyLink, Inc. (“CenturyLink”) and Level 3 Communications, Inc. (“Level 3,” and together with CenturyLink, the “Applicants”) reported that they spoke by telephone with the staff of the Commission’s Wireline Competition Bureau (the “Bureau”) and Office of General Counsel, during which time the Applicants expressed their intent to clarify certain of their responses to the Bureau’s Information and Document Requests issued on March 30, 2017, in the above-referenced docket.¹

In furtherance of that discussion, and to supplement the Applicants’ response to RFI Number 3, which sought information and documentation pertaining to the effect of the transaction on business data services, the Applicants are submitting herewith Highly Confidential documents and supporting exhibits identifying the number of Level 3 fiber locations within 0.1 mile of an in-region CenturyLink fiber location, excluding overlap locations (previously provided) and locations in eight specified MSAs (for which other, additional information is being

provided); and, for each such location, the identity of a competitor fiber-fed location within 0.5 mile of the Level 3 location and the source of that information.²
