Lake.² KSMQ currently is carried by Jaguar only on its South Line-up and thus this Complaint is limited accordingly at this time.³

Based on its published channel guides covering its South Line-up, all television broadcast stations are retransmitted by Jaguar in both standard definition (“SD”) and high definition (“HD”) formats, with the exception of KSMQ, which Jaguar provides solely in SD.⁴ Jaguar’s failure to carry KSMQ in HD format violates Sec. 76.62(b) of the FCC rules, the prohibition against material degradation. Moreover, Jaguar’s discrimination against KSMQ by carrying it only in SD format, while offering all other television stations in both SD and HD, violates Sec. 76.62(d) of the FCC rules.

The foregoing issues were brought to Jaguar’s attention in a telephone conversation between counsel for KSMQ and Kristine Anderson, in-house counsel for Jaguar, on April 17, 2018. During that conversation, Ms. Anderson claimed that the problem was likely related to difficulties encountered by Jaguar in the transport of broadcast signals to Jaguar’s headend/signal processing facility. She promised to get back to undersigned counsel for KSMQ promptly after exploring the matter with Jaguar technical personnel. In the ensuing weeks, counsel for KSMQ

KSMQ has been unable to find any evidence that Jaguar has registered its operations through filing of FCC Form 322 regarding any of the foregoing communities as required by Sec. 76.1801 of the FCC rules. The Commission may wish to undertake its own investigation relating to Jaguar’s apparent lack of compliance with other applicable requirements, e.g., EEO (FCC Form 395-A), signal leakage monitoring (FCC Form 320), transmission on aeronautical frequencies (FCC Form 321), FCC regulatory fees, etc.

placed multiple follow-up calls to Ms. Anderson, but received no response either by telephone or email. In at least one voicemail left for Ms. Anderson, it was offered that a technical representative from KSMQ would work with a counterpart from Jaguar to resolve the matter, but this suggestion was similarly met with no response from Jaguar.⁵

Notably, unlike must-carry complaints relating to local commercial television stations, NCE stations are under no obligation to first raise their claim with the affected cable operator and demonstrate efforts to resolve the matter before filing a complaint. *Compare* 47 C.F.R. § 76.61(a) *with* § 76.61(b)(1). Nevertheless, KSMQ has provided Jaguar with ample notice of the basis of its complaint and an opportunity to resolve the situation without resort to the FCC complaint process. Because Jaguar's lack of response has extended for over two months, KSMQ has found itself with no option other than to file this Complaint.

WHEREFORE, KSMQ respectfully requests the FCC to promptly issue an order requiring Jaguar to comply with its signal carriage obligations under Sec. 76.56(a) and 76.62 of the FCC rules.

Kristine – as we agreed in our initial conversation, Jaguar Communications is in violation of FCC rules by failure to retransmit the HD signal of full power NCE station KSMQ in communities served by Jaguar's Owatonna and Rochester lineups, while at the same time retransmitting both the SD and HD signals of numerous other local stations, e.g., KAAL, KTTC, KXLT and KYIN.

You stated that the problem may be a technical issue involving the transport of signals to various portions of the Jaguar system. I have suggested that you provide contact information for the appropriate technical person at Jaguar to work with a technical representative from KSMQ to seek a resolution of the issue. However, you have failed to respond to my numerous voicemail messages over the last several weeks.

Any further dilatory tactics may require KSMQ to file a formal complaint at the FCC, which of course could lead to an investigation of other apparent violations of FCC rules by Jaguar. We continue to hope to resolve this matter in a prompt and amicable fashion.
