Re: GCI Communication Corp. Funding Year 2018 and 2019 Cost Models for Satellite and TERRA Services; *Promoting Telehealth and Telemedicine in Rural America*, WC Docket No. 17-310 – FY 2018 and 2019 Rural Rates

Dear Ms. Dortch,

GCI Communication Corp. (“GCI”) hereby submits a second erratum for its filing of June 28, 2019 in which it submitted cost models to the Wireline Competition Bureau (“Bureau”) for the Rural Healthcare (RHC) Program Funding Year (“FY”) 2018 and 2019 interstate services over GCI’s TERRA and Satellite networks.¹ In this correction, GCI makes changes to previously filed Exhibits A–H because GCI discovered that several small adjustments were required to the data contained therein. This replaces prior Exhibits A–H in their entirety. Only the corrected exhibits are attached to this erratum, as follows:

- Exhibit B: FY 2019 TERRA cost model – Adjusted July 17, 2019

- Exhibit E: Revised TERRA rates for FY 2018 – Adjusted July 17, 2019

- Exhibit G: Revised Satellite rates for FY 2018 – Adjusted July 17, 2019
- Exhibit H: Revised Satellite rates for FY 2019 – Adjusted July 17, 2019

Overall, the corrections changed the total revenues in the cost models for both FY 2018 and 2019 TERRA and Satellite services (see Exhibits A–D), which required changes to the revised rates (see Exhibits E–H).
