Union Telephone Company ("Union") has already completed construction in this SAC, and the drive test data and associated coverage files are in its FCC Form 690 Payment Request 3, which was submitted prior to the reporting period for this SAC.

During the reporting period of January 1, 2017 through December 31, 2017, though it has improved and enhanced its coverage, Union had not constructed in any additional census blocks within the subject Census Tract for this SAC. Therefore, it did not complete any coverage/performance testing for this SAC during the reporting period of January 1, 2017 through December 31, 2017.

## **TRIBAL ENGAGEMENT NARRATIVE**

In accordance with 47 CFR 54.1009 (a)(5) & 54.1004, Union Telephone Company d/b/a Union Wireless ("Union Wireless" or "Company") has engaged and is continuing to engage with representatives of the Northern Arapaho Tribe and the Eastern Shoshone Tribe in order to provide services to the Tribal land network.

### **I. Introduction**

Union Wireless has continued to contract the services of EnerTribe, Inc., a 100% native owned company that specializes in tribal government, specifically regarding communications projects.

Union Wireless's goal is to provide service to rural areas within Wyoming, including tribal lands and work with tribes to ensure positive collaboration. During the past year, Union wireless has accomplished this by working cooperatively with EnerTribe, local tribal governments as well as tribal enterprise. The tribal Governments include the Northern Arapaho Business Council (NABC), Northern Arapaho Tribal Industries (NATI), Wind River Internet (WRI), the Eastern Shoshone Business Council (ESBC), the Wind River Intertribal Council and other departments within the government. Additionally, Union has worked with the Bureau of Indian Affairs (BIA) and their department heads since the BIA is the trustee of the land on the reservation. EnerTribe has been used as a means to develop interdepartmental and governmental relations between the tribes and Union. This has been accomplished by means of periodic onsite visits, Business Council meetings, conference calls and a cohesive strategy to develop joint communications projects with both tribes.

While there are only two tribes located on the reservation, there have actually been three tribal governments involved in each project; NABC, the ESBC, and the Wind River Intertribal Council which represents the interests of both tribes. The Wind River Intertribal Council acts as the governing body in correspondence with the BIA.

### **II. Needs Assessment and Deployment Planning**

In 2012, the scope was identified to meet Tribal and FCC 901 Mobility Fund Phase I requirements. Those projects were worked to completion through the spring of 2016. On February 2, 2016, Union held a communications workshop with key players involved in communications development for the Northern Arapaho. During this discussion, current and anticipated needs for wireless and fiber optic infrastructure was discussed leading to the proposal of two new projects included below (Arapaho Water Tank and Arapaho to Hudson Fiber). In addition to that, several other tower locations were discussed for more long-term benefit. Those projects will be further developed at a later date. Please see attachments for the agenda of this meeting.

Representatives of the Company met, and engaged in substantive discussions, with representatives of the Eastern Shoshone Business Council on January 15, 2013. During this meeting, the scope was identified to meet Tribal and FCC 901 Mobility Fund Phase I requirements. Those projects were worked to completion through the spring of 2016. On February 4, 2016, Union held a communications workshop with key players involved in communications development for the Eastern Shoshone. During this discussion, current and anticipated needs for wireless and fiber optic infrastructure was discussed leading to the proposal of two new projects included above (Rocky Mountain Hall – Rooftop Wireless Site and Frank Wise to Shoshone Rose Fiber).

No additional needs assessments were completed in 2017 as Union is working with the tribes to complete the currently slated projects:

### III. Feasibility / Sustainability Planning

Based on previous conversations with the tribes, dating back to 2012, the best way to feasibly develop these tribal lands are to 1) Serve locations inhabited by permanent residents, 2) Reduce impact to tribal and private assets due to deployment of network infrastructure, 3) Reduce installation and operational costs for each facility.

In further discussions with the tribes, Union has also been working to strategically partner on mutually beneficial projects to maximize capital available for these builds. In this way, Union is maximizing the opportunities to serve this area now and in the future.

In addition, Tribal representatives and Union have begun conversations regarding the long-term maintenance of telecommunications infrastructure. These conversations are expected to be fully developed in 2018.

### IV. Marketing Services in a Culturally Sensitive Manner

Periodically, the Northern Arapaho and Eastern Shoshone tribes host a Cultural Synergy Conference. Union was unable to attend one of these conferences in 2017, but we hope to attend in 2018. Additionally, Union is at the exploratory level of opportunities within the business development arena with the Arapaho and Shoshone tribes. Should these prove out, lengthy additional training, business planning, reporting sessions will be required. Part of why Union is waiting to market services is Union is looking to optimize our coverage in Fort Washakie, one of the main governmental centers on the reservation so Union has a solid service to actively pursue marketing in this area. Marketing will commence as soon as the Rocky Mountain Hall site is on air.

V. Processes for: a) Right-Of-Way, b) Land Use Permits, c) Facilities Siting, d) Environmental Reviews

The Wind River Intertribal Council and the BIA now review all rights-of-way, land use permits, facilities siting, and environmental reviews. In addition to submitting proposals to the intertribal council, Union also corresponds with each tribe's business council on all projects. Please see below for more detail on these processes.

a. Right of Way Processes

For all development within tribal service areas, public record research occurs with the county and the BIA, to determine access requirements to the facility. For leases and easements on deeded lands (fee-simple lands), including those commencing from Federal, State or county public access roads, the Company negotiates with the landowner(s) of the property with oversight from the BIA or mediated by the BIA. For leases and easements across tribal-owned lands, including those commencing from Federal, State or county public access roads are reviewed by the Wind River Intertribal Council. All leases and easements are required to have tribally approved surveys and appraisals to verify fair market value and be recorded with the Bureau of Indian Affairs.

b. Land Use Permitting Requirements

Any Land Use permitting requirements are approved by the Wind River Intertribal Council.

c. Facilities Siting Rules

Site location is determined to provide the best coverage area based on the geography of the location as well as from population/area served while not infringing upon known sacred regions. In addition, landownership requirements, power location and access to the site is weighted for time frame construction feasibility. Site locations are expected to be approved by the Wind River Intertribal Council.

d. Environmental Reviews

Each site, without regard to ownership or jurisdictional requirements, are mandated for environmental review per (47 CFR § 1.1307). Input from Federal, State, Tribal, and Local entities are sought for review as well as public notice and hearings prior to site construction. If required, mitigation measures will be implemented.

VI. Cultural Preservation Reviews

Prior to site development, cultural studies are implemented from Federal/State agencies or from contracted approved cultural service firms. National Programmatic Agreement (36 CFR § 800.16(b)) guidelines are followed for the cultural review process. From these studies determination of any impact to any cultural, archeological or historical artifacts are addressed. The State Historic Preservation Office (SHPO) and Tribal Historic Preservation Office (THPO) review site locations and cultural studies. If no significant cultural impact is found, then concurrence with the study is given. If SHPO or THPO determine impact exists, then consultation is addressed at the site location for final determination. Once final concurrence is received site development proceeds. Union ensures we are in receipt of all

concurrence letters for the Northern Arapaho and Eastern Shoshone THPO offices for all projects happening on the Wind River Indian Reservation.

Thru the TCNS process tribal review typically includes the Apache Tribe of Oklahoma, Cheyenne-Arapaho tribes of Oklahoma, Comanche Nation, Eastern Shoshone Tribe, Fort Peck Tribes, Keweenaw Bay Indian Community, Lower Brule Sioux Tribe, Northern Arapaho Tribe, Northern Cheyenne Tribe, Shoshone-Bannock Tribes, Southern Ute Tribe, Upper Sioux Community of Minnesota and the Ute Indian Tribe.

Union is currently working with the BIA to determine any additional NEPA-related compliance required by their agency.

#### VII. Compliance with Tribal Business and Licensing Requirements

The Tribal Employment Rights Office (TERO) represents both tribes and oversees the majority of Tribal Business and Licensing Requirements on the Reservation. Union currently holds a business license (2017-00919) with the Shoshone and Arapaho Tribes and have obtained temporary work permits for the construction of the Ethete and Winkelman projects. For any project being undertaken on the Wind River Indian Reservation, Union will obtain temporary work permits as necessary. In accordance with the work permit, Union will seek roughly a 50% tribal hire for the completion of this portion of the project. For any major drive testing off public roads on tribal lands, a trespass letter will be acquired from the Wind River Intertribal Council and Arapaho and Shoshone Fish and Game Department.

#### VIII. Points of Contact

##### Northern Arapaho

Each project listed above requires regular communication between Union and various department heads. Union works cooperatively with Executive Secretary Debbie Antelope when working with the NABC. The NABC assigned us a project lead by working with NATI/WRI's Patrick-Adam Lawson. Patrick-Adam Lawson has been responsible for the general direction of each project by ensuring the interests of the tribe are being met both from a technical and logistical standpoint. For review of all technical matters, Union works with NATI/WRI. Additionally, Union has worked with Devin Oldman in the THPO department to ensure all culturally related issues are being addressed for each project. On legal matters (agreements etc.) Union works directly with the tribe's legal council Baldwin, Crocker & Rudd.

##### Eastern Shoshone

Each project listed above requires regular communication between Union and various department heads. Regular contact with the Executive Secretary Phoebe Wilson has proven beneficial when submitting proposals, requesting meetings with the ESBC and to assist with tribal review. Working cooperatively with Josh Mann (THPO) has helped address any cultural concerns the tribe might have. The Tribal IT Director John Brown was assigned as a project lead to ensure the tribe's interests are being met. Tribal council chairman Clint Wagon has assisted John Brown in this effort to ensure appropriate attention is being given to the future plans of the ESBC. On all legal matters, Union has been working as directed by the business council on an as needed basis. For review of all technical documents, a committee was

created by the Eastern Shoshone Business Council with point of contact being Council Chairman Clint Wagon.

#### BIA

Union representatives have met with Norma Gourneau (Superintendent), Marietta Short Bull (Realty Officer), Trisha Cachelin and Leticia Black (Realty Specialists). As the BIA is the "Trustee" for the land on the Reservation, they encouraged Union to work directly with them throughout each project.

#### Wind River Internet Company (WRI)

WRI is a subsidiary of Northern Arapaho Tribal Industries (NATI) and has plans to build out Fiber on the reservation to help provide services to the 1,000+ subscribers it currently has.

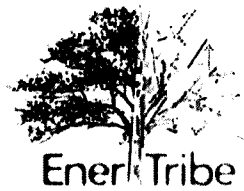
#### TERO

The Tribal Employment Rights office represents both tribes. The TERO department has helped ensure Union is in compliance to work on the reservation and hire local tribal members for projects where possible. Union works with the local TERO department during their normal business hours.

#### IX. Summary

Our mission at Union Wireless is to continue facilitating economic growth in Indian Country by working cooperatively with the Northern Arapaho and Eastern Shoshone tribes. The projects on the reservation are just a beginning of a long-term partnership between Union and the tribes.

We are proposing to place 4 antennas (3 panels and 1 microwave) with radio gear wall mounted on the exterior of the building. Cabling from the antennas would travel back to an outdoor cabinet mounted on a grated platform located on the south side of the building.

- b. *Union Wireless is checking on status of lease document. Our understanding is that the lease is ready for execution on both sides.*

❖ Fiber Project – Frank Wise Building to Shoshone Rose Casino

a. Summary of Project Status

  - b. Union Wireless is requesting Eastern Shoshone Tribal Business Council approval to proceed and preferred point of contact.*

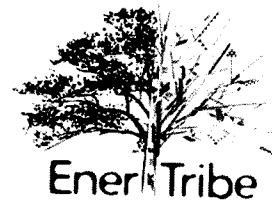


