

**2018 ANNUAL SECTION 254(G) CERTIFICATION

1. My name is Amy Linzey. I currently serve as the CEO/General Manager of WT Services, Inc. dba Hereford Long Distance ("HLD"), a provider of interstate interexchange telecommunications services as a toll reseller in the state of Texas. In this capacity, I have become familiar with the network operations of HLD and its pricing policies including compliance with Section 254(g) of the Communications Act, as amended (47 U.S.C. §254(g)).
2. HLD has provided its interstate interexchange services since 11/14/1990.
3. HLD is in compliance with Section 254(g). Specifically, a) the rates charged by HLD for interexchange telecommunications services to subscribers in rural and high cost areas are no higher than the rates charged by HLD to its subscribers in urban areas; and b) the rates charged by HLD for interstate interexchange telecommunications services to its subscribers in each state are no higher than the rates charged to its subscribers in any other state.
