Dear Ms. Dortch:

On July 17, 2019, Brian Russell, Chief Operating Officer, Aeronet Global Communications Inc. ("Aeronet"), and Roger Sherman and the undersigned of Jenner & Block LLP met with Commissioner Brendan Carr and his Legal Advisor, Will Adams. During the meeting, we discussed Aeronet's Petitions for Rulemaking in the above-captioned dockets.¹

We emphasized the benefits of Aeronet's proposed service for consumers as outlined in Aeronet's petitions and described Aeronet's ongoing trial of the service on a cruise ship in Florida as an example of the burgeoning demand for high speed broadband at sea. We also noted that these benefits could be achieved with relatively minor changes to the existing rules, and that interference concerns could be addressed through coordination procedures. Finally, we urged the Commission to move forward expeditiously to a Notice of Proposed Rulemaking consistent with Aeronet's petitions.
