At the request of Commission staff, Hospers Telephone Exchange, Inc. ("Hospers") and Mutual Telephone Company of Sioux Center, Iowa ("Mutual") (collectively, "Applicants") hereby supplement the above-referenced pending Joint Application for approval to transfer control of Hospers to Mutual.

As stated in the Joint Application, Applicants' service territory overlap is limited to the Sibley exchange which is served by Hospers competitive local exchange carrier ("CLEC") operations as well as by Heartland Telecommunications Company of Iowa ("Heartland"), Mutual's wholly-owned Incumbent Local Exchange Carrier ("ILEC") affiliate. The below supplemental information is provided for the overlapped Sibley exchange.

Number of Access Lines – Sibley Exchange

Hospers CLEC serves 141 access lines

Heartland ILEC serves 885 access lines

Competitors – Sibley Exchange

Competitors in the Sibley exchange include multiple wireless providers, including at a minimum AT&T Wireless, Verizon Wireless, T-Mobile, USCellular, Sprint.
