**REQUEST FOR WAIVER OF FORM 471 FILING DEADLINE**

The Harding County School District ("District"), Billed Entity Number 134291, filed Form 471 Number 171049130 on May 25, 2017, which was within fourteen (14) days of the May 11, 2017 Form 471 deadline. The District did not file their Form 470 application (Number 170083138) until May 1, 2017, however, which means that there was a modest reduction of the bidding period in order to submit their Form 471 application within two weeks of the Form 471 deadline. The District, therefore, petitions for waiver of the 28-day Form 470 bidding period requirement as well as the Form 471 filing deadline, due to extenuating and special circumstances that make clear that the waiver would be in the public interest.

The District has participated in E-rate sporadically and infrequently. They have applied for E-rate in only two years during the past 20 funding years and only once have they received funding. In 2000, the District unsuccessfully applied for internal connections. Due to the lack of E-rate funding, the District's 81% discount did not allow for their requests to be funded. In 2012, the District successfully applied for telecommunications and Internet access services and received E-rate benefits totaling \$3,889.45. This amount - \$3,889.45 – is the sum total of their E-rate benefits during the program's 20 year history.

The District is very small and covers a large geographic area in a very rural part of South Dakota. In the fall of 2016 District had a total of about 202 students enrolled in three elementary schools, and a middle school and high school. One of the elementary schools shares a campus with the middle school and high school. The District qualifies for a 60% C1 and C2 E-rate discount. Because of the phase-out of voice phone services, the District did not qualify for any voice service discounts in FY 2017. These 202 students are drawn from 2,678 square miles throughout the county.

The District has been uninformed about E-rate for many years and did not have the resources to try to apply for E-rate. Despite its efforts to try to understand the program's requirements, it did not have in-house expertise and could not afford to pay a consultant for assistance. Recently, the business manager learned "through the grapevine" in discussions with other districts' business managers that the E-rate program had been revised and that the

district may be able to obtain funding for some of their needed wireless equipment updates. Unfortunately, the District was unfamiliar with the E-rate calendar and the deadlines for posting a Form 470 and Form 471. In late April upon contacting the State E-rate Coordinator, the District learned about these deadlines and immediately took steps to file the required applications.

Ordinarily, the District would postpone its purchase of equipment and apply for funding in FY 2018 and meet all required deadline. However, the District desperately needs the wireless network equipment during the upcoming school year and cannot wait until the spring of 2018 to make this purchase.<sup>1</sup> Consequently, the District decided to post a Form 470 application as soon as they understood this requirement, which was on May 1, 2017, and to try to apply for funding in the 2017-2018 year.

The District then faced the dilemma of being unable to file the Form 471 application until more than 14 days after the original Form 471 deadline. Based on past FCC cases, the District thought it would be highly unlikely that they would be able to successfully convince the FCC to waive the filing deadline for a Form 471 that was submitted more than two weeks past the original Form 471 deadline. The District opted instead to submit the Form 470 application and to notify as many vendors as possible about the bidding opportunity and to request proposals as soon as possible. As the supporting documents in Exhibit A show, the District took the following steps to ensure that they conducted a fair and open competitive bidding process.

- The instructions on the Form 470 170083138 filed on May 1, 2017 stated the following: "We are aware that this Form 470 is being posted late and intend to seek a waiver of the deadlines with the FCC. Please submit a proposal by email to Eizabeth.henderson@state.sd.us at your earliest opportunity."
- In conjunction with the assistance of the State E-rate Coordinator, the District identified each vendor that was associated with a C2 funding request for any applicant in South Dakota in FY 2016. See Exhibit B. There were 23 total internal connections vendors, of which nine vendors only had one FRN. Given the urgency of the situation, the District focused on contacting vendors with multiple FRNs to enhance the likelihood that the vendor would provide a price quote in response to the Form 470. Using the SPIN search tool, the phone number for each of the 14 vendors with more than one FRN was found. Each of the 14 vendors was called and an email address was requested so that the Form 470 application and request for price quote could be sent to the vendor. In all, eight vendors were emailed a copy of the Form 470 application along with this cover email:

"Dear Vendor:

Attached please find our District's E-rate Form 470 posting for 23 wireless access points, related licenses, controller and maintenance/support as well as

installation. We know this is posted late. However, in past years, the FCC has allowed applicants to seek a waiver of the Form 471 filing deadline provided that they submit their application no more than 14 days after the 471 deadline. This year's Form 471 deadline is May 11, so the 2 week grace period would end on May 25. We therefore are asking for your assistance and cooperation in submitting a proposal by May 24<sup>th</sup> so that we have time to review your bid, discuss any questions and submit our Form 471 by the May 25<sup>th</sup> informal two week grace period deadline. We know that technically the 28 day waiting period ends on May 29 so we are asking for your cooperation. Our district desperately needs the new equipment so your assistance would be greatly appreciated. Please contact me if you have any technical questions and I will put you in touch with our technology coordinator."

The procurement was quite basic and was for the replacement of 23 access points and licenses and controller for the combined elementary, middle and high school building. There was no manufacturer's preference.

In response to the Form 470 application and related emails, the District received five proposals. Not one vendor objected to the truncated deadline or requested additional time. None of the vendors that the District contacted expressed any objection to the shortened bidding period or stated that they were unable to submit a proposal by May 24<sup>th</sup>. The fact that multiple proposals were received is a testament to the District's efforts to ensure that vendors were aware of this bidding opportunity and that there truly was a competitive procurement conducted despite the fact that it was shortened by a few days.

The District selected the lowest cost proposal as the most cost effective, and made the final decision on May 25, 2017 which was four days prior to the end of the 28 day bidding period. The District then filed its form 471 application 171049130 and is now filing this waiver request.

### ***Grounds for Waiver***

The waiver of the Form 471 application deadline is based on FCC prior cases, such as *Requests for Waiver and Review of Decisions of the Universal Service Administrator by Academy of Math and Science et al.; Schools and Libraries Universal Service Support Mechanism*, CC Docket No. 02-6, Order, 25 FCC Rcd 9256, 9259, para. 8 (2010) (Academy of Math and Science Order) (finding special circumstances exist to justify granting waiver requests where, for example, petitioners filed their FCC Forms 471 within 14 days after the FCC Form 471 filing window deadline).

The waiver of the Form 470 application 28-day bidding requirement (47 C.F.R. Section 54.504(b)) is based also on prior cases where the FCC has waived this requirement where good cause exists. For example, in *Aberdeen School District Request for Waiver*, FCC 07-63 (May 8, 2007), the FCC waived the 28 day bidding requirement for various applicants. The FCC stated:

We have examined the facts of each of these appeals and found that a waiver is warranted based on the circumstances presented and based on the facts that there is no evidence of waste, fraud or abuse. The goal of the competitive bidding process is to ensure that funding is not wasted because an applicant agrees to pay a higher price than is otherwise commercially available. We find no indication in the record that, as a result of these errors, applicants benefited from their mistakes or that any service provider was harmed. Specifically, there is no evidence in the record that other bids were not considered because these applicants did not fully comply with our competitive bidding rules. We find that the policy underlying these rules, therefore, was not compromised due to Petitioners' errors..... Furthermore, we find that several of these Petitioners, while not waiting the full 28 days before entering into an agreement, only missed the 28-day deadline by a minimal number of days (i.e., one to three days) and therefore their requests for discounted services were subject to competitive bidding for a meaningful period of time. While we emphasize that our competitive bidding rules are important to ensure a fair bidding process, we find that denying these Petitioners requests for funding would create undue hardship and prevent these potentially otherwise eligible schools and libraries from receiving E-rate funding.

*Id. at ¶9.*

We believe that the District's situation here fits within the narrow exception carved out from the Aberdeen appeal decision. The District fully considered all bids, made sure that a wide group of vendors was aware of the bidding opportunity and were invited to submit proposals, and the contract was signed only four days prior to the end of the bidding period (and three of those four days were on weekends and holidays). As a practical matter, the last day to submit a proposal would have been on May 26<sup>th</sup>, which was just one day prior to the date that the District decided on the vendor and signed a contract.

The 2007 Aberdeen appeal decision has been cited more recently with favor by the FCC. For example, in the March 2016 Streamlined Decisions Public Notice, the FCC approved the appeal of the Platte Valley School District's request for waiver of the 28 day bidding deadline (filed on June 11, 2012) even though that district had signed their contracts prior to the end of the 28 day bidding period. See Streamlined Resolution of Requests Related to Actions by the Universal Service Administrative Company, DA 16-334 (released March 30, 2016) at page 5, Footnote 16.

We believe that the current request for waiver sets forth extenuating special circumstances that justify the waiver for the following reasons:

- The District just became aware of the opportunity to file for E-rate funding on wireless equipment purchases and immediately took steps to comply with program rules upon learning of these requirements, by sending emails to numerous potential bidders, reviewing all bids and selecting the most cost effective (and lowest cost) bid.



- The District notified the vendors of the truncated response due date and explained why the date was shortened.
- The District has not engaged in any waste, fraud or abuse regarding its inadvertent non-compliance with program requirements.
- The District desperately needs the equipment and cannot postpone the purchase and apply for funding in FY 2018-19.
- The District's modest request for funding (\$8,924.35) is significant to them and will assist them with their budget and at the same time it will have an inconsequential effect on funding demand.

We hope that the FCC will agree that the District's request for waiver has merit and should be approved, so that the Form 471 application can be moved back to the "in the window" and processed for a funding commitment decisions letter.
