Traffic to be migrated to the Selinsgrove DMS100 switch includes, but is not limited to, Inter-Lata access traffic (including Feature Group B and D traffic), Intra-Lata traffic and local traffic. Network trunks will be interconnected through the Selinsgrove DMS100 switch. Once these changes are completed, the Selinsgrove DMS100 switch for the NPA NXX code that is currently native to the Pine Grove DC0 remote switch will be reflected in the Local Exchange Routing Guide (LERG).
